COOKIE POLICY

Kuş Otelcilik Yatçılık Turizm San. ve Tic. A.Ş – MİA CASA HOTEL ("HOTEL"), uses cookies to make the use of our website easier and to personalize the site for users. With this policy, you can have detailed information about the cookies used.

What is a Cookie?

Websites you visit can save information on your computer or phone, and read this information when you visit the same site later. The files where this information is saved are called cookies or identification information.

What Types of Cookies Do We Use and For What Purposes?

The cookies listed below will be used (a) for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject, or (b) with your explicit consent, depending on your explicit consent.

Analytical/Performance Cookies

These cookies are used to improve the operation of the website. These cookies, which do not collect identification data about your visits, collect data about how the website is used and whether there are any errors.

Functional Cookies

These cookies allow the website to remember the preferences of users who use the website (e.g., user name, password, preferred language, etc.). These are functional cookies that we use with your permission when you visit the website.

Necessary Cookies

To Whom Are Cookies Transferred?

Personal identification information obtained through cookies may be shared with cookie providers both domestically and internationally within the scope of the purposes stated in Article 2 of this Policy, provided that it does not harm the fundamental rights and freedoms of the data subject and with your explicit consent.

Management of Cookies

You can delete or manage cookies used by the website through the browser you use.

Data Obtained Through Cookies

Through cookies obtained through the website, personal data such as your IP address, user identification information, website entry date information, language preferences, search queries, the browser and operating system you use, and personal data about how often you visit the website may be obtained.

Your Rights Regarding Personal Data Processed Through Cookies

Within the framework of the law, you can apply to HOTEL to:

- (a) Learn whether your personal data is processed,
- (b) Request information if your personal data has been processed,
- (c) Learn the purpose of processing personal data and whether they are used for their purpose,
- (d) Know the third parties to whom your personal data is transferred domestically or abroad.
- (e) Request correction of your personal data in case of incomplete or incorrect processing,
- (f) Request the deletion or destruction of your personal data,
- (g) Request notification of the transactions made pursuant to subparagraphs (e) and (f) to third parties to whom your personal data is transferred,
- (h) Object to the occurrence of a result against you by analyzing your personal data exclusively through automated systems,
- (i) You have the rights to demand compensation if you suffer damage due to the unlawful processing of your personal data.
